## Notice of Impacts to Wetlands in Accordance with Section 2(b) of Executive Order 11990, Protection of Wetlands

**PROJECT:** Wildlife Hazard Removal Project

**LOCATION:** Jacksonville International Airport (Jacksonville, Duval County, Florida)

**SPONSOR:** Jacksonville Aviation Authority

Pursuant to Section 102(2)(c) of the *National Environmental Policy Act* (NEPA) of 1969, the Jacksonville Aviation Authority (JAA) is making available for public and agency review and comment the Draft Environmental Assessment (EA) for the Wildlife Hazard Removal at the Jacksonville International Airport (JAX). After review of the EA, and consideration of comments from the public and federal, state and local agencies, the Federal Aviation Administration will make a NEPA determination on the Proposed Project.

**Project Description**: Prior studies and wildlife surveys at JAX identified several wetland areas at the approach end of Runway 26 as hazardous wildlife attractants. The airport's Wildlife Hazard Management Plan recommends eliminating these wetlands to maintain a safe operating environment. The proposed project will remove approximately 52.8 acres of wetland habitat by clearing vegetation within the wetlands and placing fill within cleared areas to prevent the accumulation of water. The cleared areas will be maintained as mowed field. Compensation for unavoidable wetland impacts will be provided through the acquisition of credits in one or more approved wetland mitigation banks. The Draft EA did not identify any significant impacts associated with the project.
