This **Amendment No. 4** is made and entered into as of the last date of the signature below (the “Amendment”), by and between the Jacksonville Aviation Authority, a Florida public body politic and corporate whose address is 14201 Pecan Park Road, Jacksonville, Florida 32218 (the “Authority”) and Accenture LLP (formerly known as Navisite LLC) an Illinois limited partnership whose address is 500 W Madison St., Chicago, IL 60661 ( the “Contractor”), regarding the Agreement by and between the Parties dated May 1, 2021, for Oracle eBIZ Maintenance and Support Services (“Agreement”).

*RECITALS*

**WHEREAS**, on or about May 1, 2021, the Authority entered into an Agreement for Oracle eBIZ Maintenance and Support Services with the Contractor;

**WHEREAS**, the Agreement contains a provision that, at the sole discretion of the Authority, permits the Parties to renew the Agreement at the prices, rates, fees, percentages, or discounts contained in the Agreement;

**WHEREAS**, on or about April 26, 2024, the Parties exercised the renewal of the Agreement pursuant to Amendment No. 01;

**WHEREAS**, on or about September 18, 2024, the Parties amended the scope to include Oracle licenses and other related licenses to support the Authority’s technology requirements, including existing and new modules that the Authority may desire to implement in the future pursuant to Amendment No. 02;

**WHEREAS**, on or about November 1, 2024, the Parties amended the Agreement to reflect the assignment of the acquisition of Navisite LLC to Accenture LLP pursuant to Amendment No. 03;

**WHEREAS**, based on the operational needs of the Authority, the Authority and Contractor desire to extend the agreement on a month-to-month basis through October 31, 2026, or until the Authority awards a new contract for services, whichever the earlier.

**NOW THEREFORE**, THE PARTIES, BASED UPON MUTUAL CONSIDERATION, THE SUFFICIENCY OF WHICH IS ACKNOWLEDGED, AGREE AS FOLLOWS:
