- *Aircraft that do not depart or push back from gate parking envelopes at designated times within operational reason, and which may prohibit other aircraft from utilizing same gate, will be charged 1st, 2nd and subsequent hour overtime rates, as applicable.
- (11) Per-Use Joint-Use charges are in addition to per use or per turn rates and apply to all aircrafts with landed weights above 28,500. Joint use areas include the baggage makeup, tug drive lanes and baggage claim.
- (12) Rate for per turn or per use includes joint use charges for aircrafts with landed weights 28,500 or less. Aircrafts with landed weights over 28,500 do not include joint use charges and the per use joint use charge would apply.
- (13) Additional charges will apply for landing fees or any other applicable Authority fees and charges.
- (14) Per use fee for usage of international customs facility.
- (15) Not to exceed 14 hours. Cargo aircraft parking in excess of 14 consecutive hours must be coordinated with the Authority.
