QUESTIONS & ANSWERS

- Q1:** Could you please confirm whether we may submit more than three references?
- R1:** No.
- Q2:** The Draft Contract, Article 25 (Scrutinized Companies), references Exhibit E – Scrutinized Company Certification, which does not appear to have been included in the RFP materials. Could JAA please provide a copy of this exhibit?
- R2:** The Scrutinized Company Certification is attached.
- Q3:** The Draft Contract, Article 25 (Scrutinized Companies), contains a reference to “Honeywell.” Please advise whether “Honeywell” should be replaced with “JAA”.
- R3:** “Honeywell” should be replaced with Authority.
- Q4:** The Draft Contract, Article 32 (FAA Approval), states that the contract may be subject to FAA approval. Please advise if the contract resulting from this solicitation will, in fact, be subject to FAA approval.
- R4:** No, will not be subject to FAA approval.
- Q5:** Section 3.04 of the RFP states that JAA will not accept modifications or exceptions to the Contract. Please advise how respondents should handle instances where they cannot agree to specific contract provisions as written, and whether noting exceptions in a proposal would result in disqualification.
- R5:** All modifications and exceptions to the Contract should be submitted in accordance with Article 1.06 of RFP No. 26-21-25001.
- Q6:** The RFP states that the proposal is limited to 30 one-sided pages, with cover letters, dividers, appendix forms, business licenses, and references excluded from that count. Please advise whether Article IV (Proposal Form) and Exhibit B (Affidavit of Foreign Concern and Human Trafficking) count toward the 30-page limit.
- R6:** Article IV (Proposal Form) and Exhibit B (Affidavit of Foreign Concern and Human Trafficking) does not toward the 30-page limit.
