## Amendment No. 1 to the Agreement between Jacksonville Aviation Authority and Siemens Industry, Inc. for

## Fire Protection System Maintenance and Repair Services

**This Amendment No. 1** is made and entered into in duplicate this 10<sup>th</sup> day of February, 2025, by and between the Jacksonville Aviation Authority, a Florida public body politic and corporate whose address is 14201 Pecan Park Road, Jacksonville, Florida 32218 (the "Authority") and Siemens Industry, Inc.
