#### **BACKGROUND:**

The Jacksonville Aviation Authority (JAA) and the State of Florida Department of Transportation (FDOT) intend to enter into a new maintenance agreement that establishes the various rights, duties and responsibilities associated with JAA's maintenance of the portion of Airport Road (SR 102) between the Jacksonville International Airport and I-95 (Project Area).

JAA and FDOT have previously entered into an Interlocal Agreement for Maintenance and FDOT has agreed to reimburse JAA for the costs associated with maintaining the landscaping of the Project Area. Inasmuch as the current FDOT Agreement will expire on September 16, 2025, Engineering & Facilities requests authorization to enter into a new agreement with FDOT. The initial period of the new agreement will be effective September 17, 2025, through September 16, 2028, during which period FDOT will remit \$12,300.25 per quarter, for a total annual amount of \$49,201.00 for each year of the three-year agreement.

#### **RECOMMENDATION:**

Engineering & Facilities requests authorization to enter into a new properly noticed agreement with Florida Department of Transportation (FDOT) pursuant to Section 2.05(A)(10) of JAA's Procurement Code, for JAA's maintenance of the portion of Airport Road (SR 102) between the Jacksonville International Airport and I-95. 

#### **BACKGROUND:**

In 2018, the Jacksonville Aviation Authority's (JAA) Awards Committee approved an award to "piggyback" or utilize Lee County Port Authority RFP No. 15-07 for distributed antenna system (DAS). JAA currently utilizes DAS for the 800 MHz radios used by Operations and Public Safety and Security, as well as cellular phone coverage throughout the Jacksonville International Airport (JAX) campus. Use of DAS has resolved the issue of "dead" spots in JAX locations previously experienced by members of Operations and Public Safety and Security, and JAA receives revenue shares up to 40% for cellular carriers that have joined the DAS.

Business Development contacted Procurement requesting approval to extend the current DAS contract. The Lee County Port Authority contract expires in September 2026 with no renewal options; therefore, JAA is unable to extend its contract. Market research indicates there are no other government or cooperative contracts available to piggyback. There is market competition for DAS; however, in consideration of the construction of the new Concourse B and new parking garage, it is in JAA's best interest to standardize on the DAS operated by Crown Castle Fiber, LLC. Conducting a Request for Proposals may result in the DAS installation in Concourse B and the new parking garage to occur after the appropriate construction phase resulting in additional cost to JAA and a lapse in critical communications service.

Therefore, JAA requests authorization to negotiate a five-year contract with Crown Castle Fiber, LLC, for the continued operation and maintenance of the existing DAS, as well as future expansion of DAS, as JAA may be deemed appropriate.

#### **RECOMMENDATION:**

Business Development and Information Technology formally request permission pursuant to § 3.01(C) of the JAA Procurement Code, to establish a properly noticed standardization of Crown Castle USA, Inc.'s Distributed Antenna System, for a period of five years after the date of final approval, with JAA's discretion to renew or continue standardization after conducting market research, and such approval will result in contract extensions of five-year increments. JAA, in its sole discretion, may negotiate new contract terms and conditions with Crown Castle USA, Inc. at time of renewal or continuation. This is a revenue generating contract.

#### **BACKGROUND:**

The Jacksonville Aviation Authority (JAA) currently owns four Runway Closure Markers (two primary and two backup) at the Jacksonville International Airport (JAX). The Federal Aviation Administration requires runway surfaces that are closed for an extended period to be identified by positioning a portable lighted marker or similar markings on the first usable portion of the runway surfaces (both runway ends). The standard aviation industry practice for runway closures is to utilize this type of portable lighted marker, commonly referred to as a "Lighted X". The units have extendable components that increase flight crew visibility and awareness to a closed runway. Supported by a self-contained generator, the units illuminate for periods of adverse meteorological conditions and nighttime use.

In October of 2023, JAA's Awards Committee approved JAA Award No. AC2023-10-15 for two Runway Closure Markers. The other Runway Closure Markers at JAX are over 19 years old, and they have reached a point at which the generator and related components are prone to failure and some parts have become obsolete. We also anticipate needing "Lighted X's" at JAA's General Aviation airports and request permission to pursue the same as part of this award.

Pursuant to Sections 2.05(A)(12) and/or 3.08 of JAA's Procurement Code, Procurement has reviewed favorable pricing of General Services Administration (GSA) Contract No. GS-07F-182GA and is of the opinion that it is in JAA's best interest to continue utilization of the GSA contract, which was competitively awarded to Goldwings Supply Services, for a term through August 31, 2027 and any exercised renewals under the available contract.

#### **RECOMMENDATION:**

Engineering & Facilities recommends JAA Award No. AC2023-10-15, awarded to Goldwings Supply Service, Inc. for industrial products and services, be amended to: (i) include the purchase of additional Lighted X runway closure products and services; and (ii) increase the not-to-exceed amount by an additional \$150,000.00, through August 31, 2027, and any exercised renewals available under the utilized contract, resulting in a new potential not-to-exceed award total of \$205,000.00. Funds are budgeted within various cost centers.

#### **BACKGROUND:**

In 2014, the City of Jacksonville's (COJ) Office of Inspector General (OIG) began operations, the jurisdiction of which was ultimately extended to all of the Consolidated Government, including the Independent Agencies (IAs) like the Jacksonville Aviation Authority (JAA).

JAA recognizes the value to the public and itself in building trust and transparency in policies and processes. As such, JAA understands that OIG plays an important role in training public officers and employees, and its oversight does not come without cost. To that end, COJ is authorized to enter into agreements with its IAs to provide funding to OIG. Consistent with Federal Aviation Administration guidance, JAA deems it in its best interest to provide such funding and administrative support to the COJ for the provision of OIG services.

JAA, along with the other IAs, entered into a Memorandum of Understanding (MOU) with COJ/OIG on October 20, 2022, to offset OIG costs in providing services for fiscal years 2023 through 2026. Fiscal Year 2023 was in an amount of \$10,000.00, and each fiscal year includes a 3% increase from the prior year's funding support amount. The annual expense has previously been informal but now requires formal Awards Committee approval.

#### **RECOMMENDATION:**

Executive Management recommends JAA's informal award to the City of Jacksonville, for funding support of its Office of Inspector General, pursuant to §2.05(A)(12) of JAA's Procurement Code, be amended to: (i) approve past, present and future invoices properly submitted pursuant to the MOU executed between the parties; and (ii) increase JAA's spending authority in the amount of \$21,536.27 through September 30, 2027, for a new potential total not-to-exceed amount of \$41,836.27.

#### **BACKGROUND:**

The joint and crack repair project at Jacksonville Executive at Craig Airport (JaxEx) and Herlong Recreational Airport (Herlong) includes cleaning and resealing of approximately 9,500 linear feet of joints and cracks in asphalt runway pavement. Pavement surface markings in joint and crack repair areas will be repainted.

On July 17, 2025, Procurement issued Invitation to Bid (ITB) No. 25-29-44302 for runway crack repairs at JaxEx and Herlong. On July 31, 2025, Jacksonville Aviation Authority received three conforming bids and Hasco, Inc. was the lowest responsive, responsible bidder.

The unit prices included in the low bid submitted by Hasco, Inc. are generally consistent with the type of work to be performed. The prices for the Herlong work are higher than the prices for JaxEx, but that is expected with the very small quantities of work at Herlong.

#### **RECOMMENDATION:**

Engineering & Facilities recommends an award be made to Hasco, Inc., the lowest of three responsive and responsible bidders to ITB No. 25-29-44302, for the Joint and Crack Repair at the JaxEx R/W 14-32 and Herlong R/W 11-29 projects, in a total potential not-to-exceed amount of \$81,550.00.

#### **BACKGROUND:**

On September 20, 2021, the Jacksonville Aviation Authority (JAA) approved JAA Award No. AC2021-09-16 to Landrum & Brown, Inc., RS&H, Inc., and Ricondo & Associates, Inc. for on-call engineering planning services. On July 19, 2024, AC2024-07-07 was approved for an additional \$183,973.00 to Landrum & Brown, Inc., for as-needed services.

Based on spend analysis, Landrum & Brown, Inc.'s costs for services have exceeded the approved spending authority from the previous award and require a ratification of \$16,380.00 for services awarded in April 2025. This ratification is necessary because the FAA funded a planning study for the runway incursion mitigation (RIM) at Jacksonville Executive at Craig Airport but did not approve the initial alternatives. As a result, JAA had to expand the scope of the study to develop new alternatives that meet FAA standards.

It is also anticipated that an additional \$175,000.00 will be necessary to handle future projects and requisitions through September 30, 2026, which is the final contract expiration.
