### BACKGROUND:

In April of 2024, the Jacksonville Aviation Authority's (JAA) Awards Committee approved JAA Award No. AC2024-04-04 to Host International, Inc., for the procurement of meal vouchers as an expression of appreciation for Jacksonville International Airport Ambassadors and Musician volunteers, for use during their shifts. In May of 2025, JAA Award No. AC2025-05-05 was approved for additional funds.

Funding is close to depletion and requires additional funding approval. Historically, the annual spend on vouchers has been approximately \$75,000.00. This award is to cover annual spend through award expiration in April 2029.

### RECOMMENDATION:

**Procurement recommends JAA Award No. AC2024-04-04 to Host International, Inc., food and beverage meal voucher purchases, be further amended to increase awarded funding by \$300,000.00, resulting in a new total potential not-to-exceed amount of \$427,000.00, to sustain services through award expiration. Funds are budgeted within various cost centers.**

### BACKGROUND:

The new Concourse B at Jacksonville International Airport will have two food and beverage concession locations in addition to the Food Hall.

On November 16, 2025, Procurement released RFP No. 26-05-43101 to contract with a qualified firm that could professionally develop, manage and operate these two Concourse B Food & Beverage Concession spaces.

On January 5, 2026, JAA received two conforming Proposals which were evaluated and ranked as follows:

Rank Order	Respondents	Scores
1	Paradies Lagardère	85.00
2	HMSHost by Avolta AG	75.25

Paradies Lagardère, the highest ranked Respondent, proposed the following concessions concepts: (i) Pura Bean Coffee Company; and (ii) Salt & Tide.

### RECOMMENDATION:

**Business Development recommends that JAA make an award to Paradies Lagardère, the higher ranked of two respondents in response to RFP No. 26-05-43101, for Concourse B Food & Beverage Concessions. The term is for a 15-year period for the following concessions concepts: (i) Pura Bean Coffee Company; and (ii) Salt & Tide. For the initial contract year, the annual rent due for this agreement is the greater of a Minimum Annual Guarantee of \$550,000.00 or annual gross revenues consisting of: (i) 11% of non-alcoholic beverage sales in Contract Years 1-5; (ii) 12% of non-alcoholic sales in Contract Years 6 – 15; and (iii) 18% of alcoholic beverage sales.**

### BACKGROUND:

The Jacksonville Aviation Authority (JAA) has a continuing need for tree trimming and tree removal services to support operations at the Jacksonville International Airport, Cecil Airport and Spaceport, Herlong Recreational Airport and Jacksonville Executive at Craig Airport.

On October 28, 2025, Procurement released ITB No. 26-03-26201 for tree trimming and tree removal services. On December 3, 2025, Procurement received three responsive bids from Eagerton Tree Service, LLC, The Davey Tree Expert Company, and Land & Home Services, LLC. Procurement recommends an award be made to the two lowest bidders, Eagerton Tree Service, LLC and The Davey Tree Expert Company, for tree trimming and tree removal services based on the bid prices in the tables referenced below. The two vendors will be utilized for services on a rotating basis and based on their availability for the location, date and time of service.

## BACKGROUND:

To achieve various efficiencies in maintenance, the Jacksonville Aviation Authority's (JAA) Facilities & Engineering Department requests permission, pursuant to § 3.01(C), JAA Procurement Code, to standardize on concourse high mast lights utilizing SpecGrade high mast LED light kits (see Exhibit "A" for product specifications). More specifically, Facilities believes it is in JAA's best interest to standardize the purchase of and continue to use SpecGrade high mast LED light kits as a standard specification, particularly as it relates to power and streamlining maintenance, for a period of five years. Facilities is confident that this standardization will result in:

1. Uniformity of high mast light photometrics and coverage;
2. Compatibility and familiarity with currently deployed equipment; and
3. Inventory consistency and reduced maintenance hours and cost currently utilized to conduct preventive and corrective maintenance on the concourse high mast lights.

This standard applies to JAA's concourse high mast lights. JAA's standard for all concourse high mast lights will be uniform with SpecGrade. Furthermore, any products and services provided by SpecGrade that are inter-operable with SpecGrade hardware would fall under this standard definition. ### BACKGROUND:

Contingent upon the approval of Award No. AC2026-01-04SR, the Jacksonville Aviation Authority's (JAA) Facilities & Engineering Department desires a general award for the on-going installation and replacement of high mast led lighting kits on an "as-needed" basis for the duration of the standardization.

SpecGrade is a proprietary product with a limited distribution system. SESCO Lighting, Inc. is the only authorized reseller in the Southeast Region for the SpecGrade LED Lighting Kits but cannot directly sell to JAA. The following electrical distributors in Jacksonville, Florida are authorized to resell SpecGrade products: (i) City Electric Supply; (ii) Englewood Electric Supply Company; (iii) World Electric Supply; (iv) Graybar Electric Company; (v) Lamp Sales Unlimited; (vi) Consolidated Electrical Supply; and (vii) Jax Electric. Authorization for purchase will be extended to any additional resellers authorized by SpecGrade over the five-year duration of the standardization.

Based upon previous spend and ongoing projects, Facilities & Engineering estimates a not-to-exceed amount of \$500,000.00 over the five-year duration of the standardization.
